

Minutes of the meeting of the Buffalo City Council, Iowa held on September 12, 2016 Meeting called to order by Mayor Doug Anderson, at 6:00 pm. Present were Council members Dave Stickrod, Art Bartleson, Joe Buffington, Olin Meador, and Sally Rodriguez, Police Chief TJ Behning, Public Works Director Art Horst, Fire Chief Terry Adams and City Clerk Tanna Leonard.

Motion by Buffington to approve the agenda as presented. Seconded by Rodriguez and carried unanimously.

Public Input

Judy Blessing spoke on behalf of her sister regarding a dog bite and attack on her dog at the Buffalo City Park. Robert Bartleson expressed his concern that certain people in the community receive special treatment and do not have to follow the same rules as everyone else.

Canine Police Patrol

Officer Bujalski presented council with a proposal to add K9 protections to the Departments tools. Costs covered by Bujalski's GI bill would be to obtain the canine and training for both. The County Attorney's office would cover squad alterations to accommodate the dog's transportation. The City expenses would be approximately \$1700-\$1800 to cover expenses during training including mileage and sleeping accommodations. The City would also need to expend annually and estimated \$2500 for vet and grooming expenses for the canine. Motion by Bartleson to approve the addition of K9 unit to the department. Council discussed the options with Bujalski and requested input from the City Attorney. Motion by Bujalski Seconded by Rodriguez and carried unanimously. Mayor put the motion to a roll call vote. Bartleson – Yes, Stickrod- No, and commented that he would like to see additional numbers for the costs and check with other agencies. Meador – No, and agreed with Stickrod. Rodriguez - Yes, and Buffington –No.

Public Works Position

Covered in public input.

Ash Street Update

Mike Janecek updated council with the progress of the project. Work was to be completed by September 3 and the contractor just had a short punch list of items to complete. Council questioned the project not being completed on time and Janecek explained he recommended that since substantial amounts of work were completed typically a fine would not be applied but the decision was for council to make. Janecek requested payment for request No5 for \$57,034.02. Council agreed to add it to their claims list.

Pay Request #1 MRT Trail

Motion by Meador to approve pay request #1 MRT Trail. Seconded by Stickrod and carried unanimously.

WWTP Sludge recirculation control

Motion by Bartleson to approve the bid from Mississippi Valley Pump for \$2,000.00. Seconded by Buffington and carried unanimously.

Jaxk's Assessment waiver

It was noted by City Attorney Bill McCullough that the assessment waiver was not required on a simple subdivision.

Motion by Rodriguez to have trick or treat October 31, 2016 from 6-8 and purchase \$400 in candy for distribution. Seconded by Buffington and carried unanimously.

Y48 Road Improvement

Public works director explained that Linwood Mining was requesting to put in a concrete crossing along Y48 so that their trucks could cross.

UTV Ordinance

Bartleson requested council consider adding UTV's to the City ordinance. He explained that he was approached by a couple of residence and had heard that Walcott recently added them to their code. Mayor asked clerk to get information and have an ordinance prepared for the next meeting.

Sidewalk Program

Buffington requested that the City review the outdated sidewalk code and consider updates. Mayor asked if Buffington could make his suggestions to the ordinance committee and provide recommendations to the council.

IMFOA

Motion by Meador to approve clerk to attend the IMFOA conference in Des Moines October 19-21. Seconded by Stickrod and carried unanimously.

Hiring bartenders for Community Center

Motion by Meador to approve the hiring of Rene Bly and accept applications for additional bartenders. Seconded by Buffington and carried unanimously.

Humane Society Contract

Motion by Stickrod to approve the Humane Society Contract. Seconded by Rodriguez and carried unanimously.

Minutes

Motion by Rodriguez to approve the minutes of August 1 & 16, 2016 amending the date for August 1st minutes from August 2nd to the 1st. Seconded by Buffington and carried unanimously.

Resolutions

Motion by Meador to approve resolution 2016-24 FY15 Street Finance Report. Seconded by Buffington and carried unanimously.

Motion by Bartleson to approve resolution 2016-26 Transfer of Local Option Sales Tax. Seconded by Rodriguez and carried unanimously.

Motion by Rodriguez to approve resolution 2016-27 Bank Depository for Bingo. Seconded by Bartleson and carried unanimously.

Motion by Meador to approve resolution 2016-28 FY16 Transfer Reserves. Seconded by Stickrod and carried unanimously.

Ordinances

Motion by Bartleson to approve the second reading of ordinance 493 parking on Front Street. Seconded by Meador and carried unanimously.

Motion by Meador to approve the second reading of ordinance 494 Flood Plain updates. Seconded by Buffington and carried unanimously.

Motion by Meador to approve the first reading of Ordinance 495 placing signs on Jefferson Street where the apex is at the time of the third reading. Motion dies for lack of a second.

Motion by Stickrod to bring the claims to the table for review. Seconded by Rodriguez and carried unanimously.

Motion by Meador to approve the claims adding Payment to Jason's distributing for \$448.67, \$245.02 and River Valley for \$1,059.61. Seconded by Rodriguez and carried unanimously.

Motion by Meador to extend the meeting 30 minutes at 8:00pm. Seconded by Rodriguez and carried unanimously.


