

Buffalo Park Board Meeting Notes 10/21/2020

- A. **Call meeting to order:** 6:03 pm
- B. **Roll Call**
 - a. **Park Board Members** - Troy, Walt, Ashley, and Eric
 - b. **City Council** - Ted
 - c. **Public** – Mayor Sally
- C. **Possible Alternates**
 - a. Buffalo Ordinance committee passed revising Buffalo Park Board members to include Buffalo Township, instead of just City of Buffalo. This goes now to City Council, for 3 readings.
- D. **Park Cameras**
 - a. Three quotes were obtained for the Park cameras
 - i. Heartland - \$4156, only 4.1 mp on the cameras, not enough clarity for what's at stake
 - ii. Tri-City - \$8873, wifi included, 15.6 mp on the camera, 2 cameras included with 4 lenses each for almost 360 degree of vision
 - iii. Davenport Electrical Contract Company (DECCO) - \$16,508, wifi included, 15.6 mp, 1 Dual camera, 4 single cameras, 1 Triple camera
 - b. All options were discussed, including pros and cons of what is noted above
 - c. Eric made a motion to move forward with the Tri-City bid, Walt second, all in favor
- E. **Park Signs and Beach Front signs**
 - a. Brandy was not present at the meeting, no further information
- F. **Dodge Street Park**
 - a. Exercise equipment has been installed! Potentially looking at adding non-slip surface pads.
 - b. Score board still needs to be bored, mounted and set, wire will be ran when park cameras are bored
- G. **West End Park**
 - a. No updates
- H. **Baseball**
 - a. Donation will be discussed next month
 - b. Prices were found to replace the bases, mound and plugs for 2 fields
 - i. Information was available from Dick's Sporting Goods and Epic Sports
 - ii. Epic sports came in quite a bit lower at \$693.54+shipping, Walt made a motion to move forward with the Epic Sports prices, Ashley second, all in favor
- I. **Memorial/River Front/Beach**
 - a. Garbage cans – grant was approved, and 7 new trash cans were purchased
 - b. Add concrete for the flag poles – will be done next year when West End Park sidewalks are poured
- J. **Budget**
 - a. No new expenses
- K. **Public Input**
 - a. Sally gave thanks to the park board for being members and donating time to be on the committee

- i. She mentioned that the parks look good and kept up
 - ii. Asked the board to think about how we can start drawing in more people to our parks and grow Buffalos businesses as well with more people.
- b. Ted advised potentially getting a representative from the Railroad to attend a meeting and discuss some thoughts for the future
