Minutes of the meeting of the Buffalo City Council held on December 06, 2021. Meeting called to order by Mayor Sally Rodriguez, at 6:00pm. All members with a "*" after their name participated electronically for the meeting. All other participants were in the Council Chambers. Present Judy Hammons, Ted Teel, Austin Miller, Trent Adams, Joe Buffington, Public Works Director Josh Ferkel, City Engineer Mike Janecek*, City Attorney William McCullough, Police Chief TJ Behning, Police Sergeant Josh Bujalski, Fire Chief Doug Anderson* and City Clerk Tanna Leonard.

Motion by Adams to approve the consent agenda. Seconded by Teel and carried unanimously.

Public Input- Mayor Rodriguez Commented the following:

- 1. She welcomed re-hired employee Jay Wilson as Police Officer.
- 2. She updated numbers for Blue Line paid citations:

481 – 11 mph- 20mph

23 – 21mph-25mph

- 4- 26mph-30mph
- 3. The Fire Department would be doing the Christmas truck December 24 & 25.
- 4. She reported that with all the break-ins that were posted on Facebook, not one person filed a police report. She informed residents that even though items were not taken from the vehicles, it is a crime to break into a vehicle. She reminded the public to call 911 or the non-emergency number for Scott County 563-388-3904 to contact the police, when they see something or someone suspicious. A report of suspicious activity could prevent your neighbor or friends from being taken advantage of.

Christina McDonough, from the Scott County Health Department introduced herself and summarized some of the work that she has done with Buffalo in the past. She explained that the Scott County Health Department supports the MRT Extension and looks forward to working with the committee and citizens to make the next phase possible.

Dean Mathias aka "Bareback", introduced himself to the council and thanked them again with supporting the extension of the MRT Trail. He explained that he worked with staff and citizens to get the first length of trail through Buffalo and would support the extension however, even through pancake breakfasts like we have done in the past. He introduced Jim Mathis and David Cooney.

Jim Mathis introduced himself as the previous president of Buffalo Savings Bank previous to the changeover to SENB and thanked all the members of the Council and members of the past for supporting his dream of a trail in Buffalo that started over 20+ years ago. He was thankful for the support for making that happen and thanked the Council. He expressed his support for the extension of the trail and offered his assistance.

David Cooney introduced himself as a member of Muscatine Cycling Club and thanked the Council for continued support for the extension of the trail. He offered to show support by attending fundraisers and any other support needed.

Kathy Wine introduced herself as the Director of River Action. She expressed River Action's work in the extension of the MRT trail through Scott County and on the Illinois side of the Mississippi. She was eager for Buffalo's movements forward with the expansion of the MRT trail and announced that River Action would donate the first \$1,000 to begin to promote the next phase to YMCA Camp Abe Lincoln.

Ms. Wine also informed the Council about the Community Rating System and Flood Resilience Committee that River Action has started. The committee works with communities to improve flood mitigation. She explained that there is funding to assist with first floor surveys to help reduce or alleviate flood insurance. She also discussed working with the Scott County Flood Plain Manager with a 28E Agreement.

Mayor Rodriguez thanked all the non-resident members that came to support the MRT Trail, she appreciated the patience and confidence they had, and continue to have, in improving Buffalo.

Kay Willet addressed the Council and explained that a comment that was made by a member at a previous meeting did not sit well with her. The comment was that several people that signed her petition didn't even know what they were signing. She was upset by this because she said it made her feel uncomfortable and that the comment was just dumb if people are signing things and they don't know what for.

Teel commented that he made the comment because he had talked to some of the neighbors. He apologized and explained that he had no intentions to make her feel that way about the comment and he simply meant that they may not have had all the information before signing, and signed it to be courteous, or worried about hurting someone's feelings.

Engineering updates

Janecek updated the council:

- Street Scape- Janecek explained that he was having difficulties in the two blocks west of Dodge Street and historical ROW's with the Railroad. He was hoping to have some breakthroughs soon and meet with Community Development to discuss moving forward.
- Scott County Sewer Connections- No updates available.

 Gemetery – Janecek explained that he has been working on creating a map for the cemetery, they were working on the last few changes and meeting with St. Peters Cemetery to work out some boundary issues.

Dodge Street, Jefferson Street, Hacker Street, Franklin Street, Utah Ave, and Valley Heights Road. These streets shall be designated as snow emergency routs and if a "snow emergency" is declared no parking shall be allowed on these streets. Motion carried unanimously.
