Minutes of the regular council meeting held November 14,2022 at 6:00pm. Present council members Joe Buffington, Brandon Berg, Austin Miller, Ted Teel and Mary Moore. Mayor Sally Rodriguez, Chief TJ Behning, Sgt. Bujalski, Public Works Director Josh Ferkel, City Attorney William McCullough, City Engineer Mike Janecek, Fire Chief Doug Anderson (electronic), and City Clerk Tanna Leonard present.

Meeting called to order at 6:01p.m. by Mayor Rodriguez.

Motion by Teel and seconded by Miller to approve the consent agenda. Motion carried unanimously.

Motion by Moore and seconded by Teel to open the public hearing for the FY23 budget amendment. Motion carried unanimously.

### Clerk read the summary of amendments:

Public Safety - \$90k Fire Department turnout gear, \$150k Police Squads, Public Works - \$80k Street sweeper, \$31k side-by-side, \$49k Truck, \$10,700 Snowplow and \$68k to resurface Jefferson Street, Business type/Enterprise - \$5k Truck and \$15.5k electric poles and installation.

There were no other questions or comments from the public.

Motion by Teel and seconded by Berg to close the public hearing for the FY23 budget amendment. Motion carried unanimously.

### **Public Input**

Mayor Rodriguez provided the following public input comments:

She thanked Brandy, Tanna, Linwood, Scott County Waste, ladies at the bank and everyone else that helped with the Halloween party for the kids.

She thanked Donnie and Dynae for organizing the Halloween parade and all the participants and folks that helped with the parade.

She reminded everyone that the parks are closed at 7:00 pm now.

She said that she met with the School Board superintendent and president about the items they are working on and invited them to come to a future council meeting, as well as to continue to have meetings with them.

### **Leachate Disposal Scott County Waste Commission**

Bryan Seals explained where the Leachate comes from and the current disposal process. The current process takes the leachate to Davenport to be treated. Council would discuss the potential for expanding the wastewater treatment facility for treatment in Buffalo.

### Trees at park \$7,500

The Scott County Waste Commission had planted trees at their location several years ago. They had discussed what they were going to do with these as they were reaching the maximum size for relocating. Mayor Rodriguez had met with them and the Waste Commission was generous enough to donate these trees to Buffalo to replace the dead trees that were removed from the Terry Adams Memorial Park.

Motion by Teel and seconded by Miller to approve the Park Board request to spend \$7,500 for the relocation for trees from the Waste Commission to the Terry Adams Memorial Park. Motion carried unanimously.

#### **Street Scape**

Janecek updated the council on the status of the street scape application to the IDOT.

#### **Dollar General**

Mayor Rodriquez explained that the last update that she had heard was the outing club was still negotiating on their property with Mr. Kautz

### **Vehicle Theft inspections**

Chief TJ Behning explained that the service is provided to permit people to obtain salvage titles for vehicles that were repaired. He said that Officer Carson had been performing the inspections from Princeton but since his retirement he wanted to perform these with the revenue going to Buffalo PD. Chief Behning said he would wait for Carsten to be present to explain the program. No action taken.

#### Railroad

Mayor Rodriguez explained that an engineer had been through town and had planned on talking to Walt from Upper Mississippi to discuss the Fire Department utilizing the crossing to put the emergency rescue boat in the water.

#### **Nuisance Code Review**

Mayor Rodriguez asked the council what they found or noticed when looking around town at nuisance violations. Comments were made regarding excessive vehicles at certain locations. Attorney said that these uses may not meet zoning codes and that he could investigate it. Teel commented that although this is a small town and things are lenient but that some people are getting excessive and affecting their neighbors. It was also discussed the height of grass, living in tents, and parking in front yards. The council referred these suggestions to the ordinance committee.

### **Change Name West End Park**

Motion by Teel and seconded by Berg to approve the Park Board request to change the name of the West End Park in appreciation of Chief TJ Behning's continued dedication to the community of Buffalo. Motion carried unanimously.

#### **Utility Disconnect Process**

Teel asked how the current disconnect process works. Deputy Clerk explained the process currently followed. City Clerk explained that each utility has a little different requirement for disconnection and even that some state codes for electric disconnects were not accurate in the code. Council agreed that the delinquent accounts needed to be addressed and the policies needed to be uniform and updated. Motion by Teel and seconded by Berg to have the ordinance committee review the codes and have them updated.

### Firearms Training Certification H. Wilson

Motion by Teel and seconded by Berg to approve Officer H. Wilson to attend firearms training certification. Motion carried unanimously.

#### **COVID Funds**

Mayor Rodriguez asked if council had thought about how to spend the remaining ARPA funds. Clerk reported that Buffalo had received \$191,958 in funding, \$51,170 had been expended for repairs at the water plant,

\$28k for Water Capital Improvement Plan, and \$28k for Sewer Capital Improvement Plan. There was a balance of \$84,788.

Mayor mentioned that there was previous discussion about money being allocated towards businesses. Teel discussed the idea he favored with a utility "holiday", for only residential accounts.

Berg mentioned the use towards the utilities or infrastructure. Moore asked if those funds could be used to paint the water tower.

Motion by Teel and seconded by Berg to use \$19.5K of ARPA funds to perform a leachate study on the Wastewater Treatment Plant. Motion carried unanimously.

#### **Clerk Contract**

Teel explained that the Employee Relations Committee had met prior to the council meeting to discuss the clerk's contract. He said there was requests to change language for severance pay, schedules being approved by mayor, professional development and wage increases of \$1.00 for each year. The committee requested that the contract date be amended to correspond with the union contract, and end on June 30, 2024.

Motion by Teel and seconded by Moore to approve the revised clerk contract. Motion carried unanimously.

Motion by Teel and seconded by Buffington to approve resolution 2022-48 approving the first budget amendment of FY23. Motion carried unanimously.

Motion by Buffington and seconded by Moore to approve resolution 2022-49 approving the updates to the Buffalo Community Center manual. Motion carried unanimously.

Resolution 2022-50 had already been approved.

Motion by Buffington and seconded by Teel to approve resolution 2022-51 approving the Street Finance Report. Motion carried unanimously.

Motion by Teel and seconded by Buffington to approve 2022-52 approving the Annual Finance Report. Motion carried unanimously.

Motion by Teel and seconded by Buffington to approve 2022-53 approving the transfer/uses of ARPA funds. Motion carried unanimously.

Motion by Teel and seconded by Miller to approve 2022-54 approving the renaming of West End Park. Motion carried unanimously.

Motion by Buffington and seconded by Berg to approve the third reading of ordinance 549 approving the increase in Sewer. Motion carried unanimously.

Motion by Buffington and seconded by Berg to approve the second reading of ordinance 550 approving the increase in spending allowance for Public Works Director. Motion carried unanimously.
