Motion by Miller and seconded by Roman to approve the contract with Culpeper and Merryweather Circus and for Community Development to sponsor the event. Motion carried unanimously.

Motion by Roman and seconded by Adams to approve Resolution 2024-24 authorizing and approving a Loan Agreement, providing for the issuance of \$2,905,000 General Obligation Corporate Purpose bonds, Series 2024A, and providing for the levy of taxes to pay the same. Motion carried unanimously.

Ferkel explained that the sampler equipment is an \$8,000 piece of equipment and the refrigeration assembly went out and needed to be replaced. The cost of the item was \$2,520.00.

Motion by Teel-Vanderpool to approve the purchase of the refrigeration assembly for 4700/5800 Samplers and to pay with ARPA funds. Motion carried unanimously.

Motion by Moore and seconded by Adams to adjourn the meeting at 6:15. Motion carried unanimously.
